#### **EXECUTIVE NEWS**

The beginning of this month has seen the onset of the rains in earnest and although still scattered some good falls have been recorded across the country. The early crops that we have seen to date are looking good and we hope that the season continues to go well for the few of us who are still farming. On the other hand there have been reports of serious crop damage by hail in the Nyazura/Headlands and Karoi districts.

On Tuesday the 30<sup>th</sup> November the Commercial Farmers' Union's Extra General Meeting was held at our offices, which had been called for at our last CFU Congress in August, where the decision was taken to specifically look at the restructuring the Union so as to create a lean mean, effective and financially viable organization.

Our focus must now, and going into the future, be one of full representation for all within our sector regardless of their current status. We at the CFU firmly believe that we have a social responsibility to all and as a result there was a need to restructure the Union to make this possible.

The EGM saw the coming together of both farmers currently farming and farmers who no longer have that opportunity, due to having lost their farming businesses, debating and strategizing in an extremely positive manner. We thank all those who participated and we now feel that we have a real workable structure in place with which we can now service all, and we encourage everyone regardless of their current positions to come back on board.

In order to implement the decisions approved at the EGM certain necessary adjustments were also proposed and agreed to be made to our CFU Constitution, which also needed to be updated following many years of valuable service to the Union.

Although the proposals may only be officially ratified and implemented at and after next year's Congress respectively it was agreed to implement most of them immediately on a trial basis. This way they could be further refined before their official acceptance in August 2011.

Members attending the meeting were also briefed on the difficulties currently being experienced in our current financial position and how we propose to generate funding to keep the Union afloat bearing in mind that total reliance on our membership to continue to fund the Union is no longer possible.

Some exciting and realistic funding proposals were put forward, one of which was the introduction and official launching of The Discounters Club, membership of which will benefit both farmers and the members of the public with the opportunities to obtain varying discounts from an increasing number of participating businesses and retail outlets across the country.

In closing the successful EGM both President Deon Theron and Director Hendrik Olivier paid glowing tribute and sincere appreciation to "Kuda" Kudakwashe Ndoro who has tirelessly served the Union's members for over 20 years in many ways, but especially as Senior Economist to the Union. Kuda has resigned and in fact his last day was the day of the meeting. The President said that he was very sad to see him go but was pleased, for his sake that he will be taking up a senior position elsewhere which would significantly improve his personal wellbeing.

Our legal advisors are still busy with an intensive study on the rather disappointing judgment which was handed down last week in the Supreme Court so unfortunately we cannot sign our name to any official statement on the outcome at this stage. We hope to be in a position to do so by next week's edition.

Copies of the judgment have been distributed to all the legal practitioners and should anyone want a copy on email they should contact the Union as we are currently experiencing some difficulty in loading the long document onto the website. We hope to overcome this soon. Despite last week's adverse ruling in the Supreme Court application for a moratorium by the Commercial Farmers' Union we have seen some positive rulings come out of the courts this week.

This week judgment was handed down in a case brought against a magistrate for the wrongful arrest of a farm manager. The result was that the magistrate was ordered to pay some US\$ 54 000 in a successful claim for damages. Earlier this year another successful claim was made against a policeman for similar charges and a similar amount was also awarded to the applicant.

In the mean time farmers should not shy away from defending themselves in the courts because despite the dramatic statements made in our Supreme Court judgment we are still finding some sympathy from other judges or magistrates who have remained courageous and impartial despite the alleged threats against them.

We also note the continued success of some of our farmers in the South African courts, which will ultimately be to all of our advantage. In this case the seizure of Zimbabwe Government assets (houses) in South Africa had been appealed against by our Government but which was turned down. It is understood that one more case will be brought before the South African Courts later this month and another is set down for early next year.

Remaining on the positive side we were pleased to read in the press about the arrest, trial and conviction of one member of a gang of highway robbers who had been preying on victims who stopped at lay-byes on the Masvingo – Beitbridge highway. Although this may be encouraging we should be aware that at least two members of the gang are still at large so we should still retain our vigilance when travelling on that portion of our national highway.

It seems that the press may not always be on the farmer's side as a Karoi farmer recently found out in an article printed in a national newspaper yesterday. It is alleged that the journalist approached the tobacco farmer to write a story about the hail damaged crop. The story printed in the paper turned out to contain numerous allegations of how farmers in that particular district were allegedly leasing farms from beneficiaries of the land acquisition programme.

Whilst we remain as purely a service organisation we are in no position to be a judge of how individuals are managing to continue farming but we have been reliably informed that the majority of those farmers who have been mentioned in the article have leased property from black commercial farmers who have title deeds.

We ourselves would be very interested to obtain information on the situation on most of the farms which are still being farmed by our farmers so that we could make a correct analysis and stop the rumours.

In the article, for example the farmer concerned is said to be one of five brothers, yet the truth is that he only has one brother.
