NATIONAL EMPLOYMENT COUNCIL FOR THE AGRICULTURAL INDUSTRY OF ZIMBABWE

COLLECTIVE BARGAINING AGREEMENT: AGRICULTURAL INDUSTRY (AGRICULTURAL ALLOWANCES FOR ALL SECTORS, i.e., AGRO, HORTICULTURE, KAPENTA, GENERAL AGRICULTURE AND TIMBER SECTORS EFFECTIVE FROM 1st OCTOBER, 2011 to 30th SEPTEMBER, 2012)

Made and entered into in accordance with the provisions of the Labour Act [Chapter 28:01] between the Zimbabwe Agricultural Employers' Organisation, the Zimbabwe Commercial Farmers' Union. Indigenous Kapenta Producers Association, Kapenta Producers Association, Agro, Horticulture and Timber (hereinafter referred to as "the employers"), as the one part, and the General Agriculture and Plantation Workers' Union of Zimbabwe and the Kapenta Workers Union of Zimbabwe, Agro, Horticulture and Timber (hereinafter referred to as "the employees" or "the trade unions"), being parties to the National Employment Council for the Agricultural Industry to amend the principal agreement published in Statutory Instrument 323 of 1993.

Now, therefore, it is recorded that the agreed new allowances for all in the agriculture industry of Zimbabwe as provided for in Statutory Instrument 323 of 1993 shall be as follows—

AGRICULTURAL ALLOWANCES FOR ALL SECTORS EFFECTIVE FROM 1st OCTOBER, 2011 to 30th SEPTEMBER, 2012.

The NEC Agriculture comprising the social parties, that is, GAPWUZ, KWUZ, Agro, Horticulture, Timber on the employees'

side and ZAEO, ZFU, ZCFU, IKPA, KPA, Agro, Horticulture and Timber on the employers' side have agreed on allowances for all sectors effective from 1st October, 2011 to 30th September, 2012.

The allowance for Agro, Horticulture, Kapenta, General Agriculture and Timber industrial sectors in the Agriculture Industry shall be as follows—
