## Customs and Excise (Suspension) (Amendment) Regulations, 2012 (No. 70)

IT is hereby notified that the Minister of Finance has, in terms of section 235 as read together with section 120 of the Customs and Excise Act [Chapter 23:02], made the following regulations:—

- 1. These regulations may be cited as the Customs and Excise (Suspension) (Amendment) Regulations, 2012 (No. 70).
- 2. The Customs and Excise (Suspension) Regulations, 2003, published in Statutory Instrument 257 of 2003 (hereinafter called "the principal regulations"), are amended by the repeal of section 9J ("Suspension of Duty on Raw Materials, Intermediate Goods, Finished Goods and Capital Goods") by the insertion of a new section 9J ("Suspension of duty on Raw Materials, Intermediate Goods, Finished Goods and Capital Goods") with the following items—
