Provided that where an application is rejected or granted with conditions, the District Forest Extension Officer shall inform the owner or occupier of his or her right of appeal under section 16.

(5) The Commission may from time to time by notice in the *Gazette* publish a standard form for any undertaking referred to in subsection (3), suitably adapted to the district, area or locality where such undertaking may apply.

Application for forest produce movement or export permit

14. (1) In accordance with section 65 of the Act, any person wishing to transport or export-

- (a) any consignment of timber exceeding 0,5 cubic metres shall, for each consignment apply to the District Forest Extension Officer in the district where the timber is procured for a forest produce movement or export permit in Form FC1 together with the prescribed fee; or
- (b) forest produce craftwork intended for sale or trade, shall apply to the District Forest Extension Officer in the district where the forest produce used to make the craftwork is procured, for a forest produce movement or export permit in Form FC1 together with the prescribed fee;

whereupon the District Forest Extension Officer shall determine whether or not to issue a permit in Form FC1A.

(2) The District Forest Extension Officer may, subject to subsection (4), refuse to issue a permit on the grounds that—

- (a) the manner in which the timber or forest produce in question is being procured in the district concerned—
 - (i) is injurious to the sustained yield of any tree species from which the timber or forest produce is derived; or
 - (ii) will likely result in
 - damage to the locality, climatic factors or soil erosion; or
 - B. interference with natural water courses or supplies; or

- C. general deterioration of the locality; or
- D. interference with or the hindrance of the natural regeneration of vegetation; or
- E. a general shortage of timber in the locality;
- OF
- (b) the restriction in the movement of the timber or forest produce concerned is necessary for the purpose of combating any fungus, bacterial or viral disease or insect or parasite pests affecting the timber or forest produce in question; or
- (c) the movement in question involves the export of timber or forest produce in contravention of Forest (Control of Timber) (Export of Unprocessed and Primarily Processed Indigenous Hardwood) Regulations, 2001, published in Statutory Instrument 112 of 2001; or
- (d) the movement in question is in contravention of section 4 of the Communal Land Forest Produce Act [Chapter 19:04].

(3) Where the movement of the timber or forest produce in question involves movement across the boundaries of two or more districts it shall only be necessary for the person wishing to transport the timber or forest produce in question to apply for a forest produce movement or export permit in the district where such timber or forest produce is obtained.

(4) If the person applying for a forest produce movement or export permit makes a written undertaking to the satisfaction of the District Forest Extension Officer to remedy or mitigate the damage, injury, deterioration or interference that may result from the procuring of the trees or forest produce in question, the District Forest Extension Officer may issue the permit subject to compliance with such undertaking.

Ø.

(5) If the District Forest Extension Officer rejects an application for a forest produce movement or export permit the District Forest Extension Officer shall notify and give reasons to the applicant concerned in Form FC1: Provided that where an application is rejected or granted with conditions the District Forest Extension Officer shall inform the applicant of his or her right of appeal under section 16.

(6) The Commission may from time to time by notice in the *Gazette* publish a standard form for any undertaking referred to in subsection (4), suitably adapted to the district, area or locality where such undertaking may apply.

Approval of agreements by local authorities in terms of Chapter 19:04

15. If a local authority within whose area of jurisdiction any communal land is located intends, pursuant to any delegation to it of the powers of the Minister under the Communal Land Forest Produce Act [*Chapter 19:04*] to—

- (a) issue a licence in terms of section 5 of that Act (that is to say a licence to exploit any forest produce situated in any natural forest or plantation growing on public or state land within that communal land); or
- (b) enter into any agreement in terms of section 6 of that Act (that is to say an agreement with any person to exploit forest produce situated in any natural forest or plantation growing on public or state land within that communal land);

the Chief Executive Officer of the local authority concerned shall notify the District Forest Extension Officer in Form FC11 or a substantially similar form together with a prescribed fee.

(2) The District Forest Extension Officer or any person on his or her behalf shall immediately upon receiving notification under subsection (1) conduct all necessary inspections and make any necessary recommendations to ensure that the forest produce in question is sustainably exploited.

Appeals

16. (1) Any person who is aggrieved by a decision of -

- (a) the Provincial Forest Extension Officer to-.
 - (i) reject an application for a licence in terms of section 6; or

- (ii) grant an application for a licence subject to conditions;
- OF
- (b) a licensing authority to-
 - (i) reject an application for a licence in the circumstances specified in section 6(5); or
 - (ii) grant an application subject to conditions in the circumstances specified in section 6(5); or
 - (iii) cancel a licence in terms of section 9; or
 - (iv) suspend a licence in terms of section 9; or
 - (v) amend a licence in terms of section 10(1)(c) or (d);or
- (c) a District Forest Extension Officer to-
 - (i) refuse permission for the cutting or removal of indigenous timber in terms of section 13(2); or
 - (ii) refuse to issue a forest produce movement or export permit in terms of section 14(2);

may appeal in Form FC12 (or in a substantially similar form) together with the prescribed fee within 14 working days from the date he or she is notified of the decision in accordance with section 6(6), 13(4) or 14(5), as the case may be.

(2) An appeal referred to in-

(a) subsection(1)(a) or (1)(i) or (ii) shall be addressed to the General Manager of the Commission and lodged with the licensing authority to whom the application for the licence was made, for onward transmission by the licensing authority to the General Manager; or

(b) subsection (1)(b)(iii),(iv) or (v) shall be addressed to the Provincial Forest Extension Officer for the district in whose province the application for the licence was made and lodged with the licensing authority for onward transmission to the Provincial Forest Extension Officer; or (c) subsection (1)(c) shall be addressed to the Provincial Forest Extension Officer for the district in whose province the notification or application for the permit was made, and lodged with the District Forest Extension officer concerned for onward transmission to the Provincial Forest Extension Officer.

(3) Subject to subsection (4), the period between the lodging of the appeal in terms of subsection (1) and its determination shall not exceed thirty days, and if the appeal has not been determined after that period it shall be deemed (except in the case of an appeal against the rejection of an application for a licence or conditional granting or suspension or cancellation of a licence) to have been determined in favour of the appellant.

(4) An appellate authority may before deciding an appeal request the appellant to make such further written submissions or supply such further information as he or she considers will be of assistance in determining the appeal, in which event the thirty day period referred to in subsection (3) shall be extended by a further period so that the appeal may be determined on a date no later than sixty days from the date when the appeal was lodged.

(5) On an appeal under this section, the appellate authority may confirm, vary or set aside the decision or action appealed against.

(6) Upon making his or her determination, the appellate authority shall notify the determination to the appellant and the licensing officer or District Forest Extension Officer concerned by remitting back two copies of Form FC12 wherein the appellate authority shall state his or her reasons for the determination.

(7) If the determination is favourable to the appellant the licensing officer or the District Forest Extension Officer shall within seven working days from the date of such notification, grant to the appellant the licence or permit in question.

(8) For the avoidance of doubt it is declared that where-

 (a) an appellant whose application for a licence or permit has been rejected or whose licence or permit is granted conditionally or whose licence has been suspended or cancelled; and

(b) the appeal has not been determined timeously in accordance with subsection (3);

such appellant has a right under the Administrative Justice Act [Chapter 10:28] to apply to the High Court to compel the appellate authority to furnish reasons why the determination of his or her appeal has not been made timeously and for such other relief that the High Court may grant under that Act:

Offences and penalties

17. Any person who provides any information in or together with an application for any licence or permit under these regulations knowing that such information is false or not having reasonable grounds for believing that such information is true shall be guilty of an offence and liable to a fine not exceeding level five or to imprisonment not exceeding six months or to both such fine or such imprisonment.
