# NEWSLETTER BY MERYL HARRISON AND THE VAWZ TEAM

Speaking of animals, St Francis of Assisi said "Not to hurt our humble brethren is our first duty to them, but to stop there is not enough. We have a higher mission – to be of service to them wherever they require it.

Lacey is a 6yr old Ridgeback bitch that VAWZ Inspectors confiscated from a local security company, she was emaciated, depressed, had biliary and weighed only 13kg.

After a week of excellent care at Avondale Vets, Lacey decided life was worth living. Paula and Brad Wheeler very kindly offered to foster her until she was fully recovered. Thanks to them she has made a full recovery and now weighs 25kg.

#### STAFF

VAWZ has pleasure in welcoming Bakhulisengomusa Ncube to our team. "Musa" is a vet nurse who since qualifying at the University of Zimbabwe has been working in South Africa but wanting to return to this country to get involved in animal welfare – good news for VAWZ !! **He told us he can also rustle up a mean Chow Mein as between jobs in Joburg he worked in a Chinese Restaurant.** 

Our small office at the Wild Life Unit on the Borrowdale Road, will be a little crowded, but my departure at the end of September should make things easier – (also a lot quieter!)

#### **EDUCATION**

Inspector Bernard Ndlovu continued with his education programme and has spoken to another 12 Primary Schools including children from Nyabira and Magunje Barracks. Once the schools reopen more visits are planned. VAWZ has also recently conducted Workshops for two local Security companies where we specifically target their Dog Masters and Dog Handlers. These have proved to be very successful with all the participants receiving a certificate. We continue to distribute copies of the Cruelty Act to Police Stations throughout Zimbabwe together with dramatic posters of Cruelty cases reminding the ZRP that cruelty to animals is a CRIME.

#### RECENT CASES.

**DOGS**.New cases involving dogs = 102 – including thin mothers and pups, off properties, continuously crying/barking, being beaten, abandoned, unwanted dogs and pups, large numbers, tied up/confined, and road traffic accidents. Follow-ups and re-checks are standard procedures.

**CATS**; 5

SECURITY DOGS: 14 Checks, several prosecutions for cruelty.

CATTLE TRUCKS: 9 cases, 3 prosecutions.,

GOATS/SHEEP: 3 Cases.

PIGS: 2 cases (including prosecution of an employee for killing a sick sow with a 14lb hammer).

**CHICKENS/GUINEA FOWL/RABBITS**: Vendors, cages of birds confiscated off the top of a Kombi, chickens being carried upside down by their feet. Inspectors from VAWZ visited Sezhube Growth Point in the Esigodini area of Matabeleland to see how the FAO/World Vision Project for rabbit and guinea fowl breeding was going. Several Agritex officials were present as was the local Councillor. Much questioning convinced us all that the scheme was well meaning but a potential disaster. When the Norwegian FAO(ZW) arrived he agreed that from the animal welfare point of view the project had not been thought through. For instance, in an area where the villagers are not even able to grow crops for their own use, they are expected to grow grain for their guinea fowl and vegetables for the rabbits. Also many of the recipients are elderly women who will be unable to walk 10ks to the nearest water source. Donors had given the villagers receiving 3 rabbits, a bag of rabbit pellets, a small roll of wire netting each, a shovel and a plastic spray gun but the recipients of the 2 guinea fowl were not given the promised grain and had no idea what they would feed them on.

This area had no rain last year and their crops were a right off.

PET SHOPS: conditions for birds being kept in captivity (one case going to the High Court).

#### HORSES: 5 cases.

LIONS IN CAPTIVITY: One case going to Court.

**RESEARCH ANIMALS**: VAWZ continues to provide greens and bedding to rabbits and guinea pigs and mice

**PUPPY VENDORS**: still receiving reports, particularly along Simon Mazorodze and Lomagundi Roads – several pups confiscated, one arrest and prosecution. VAWZ has recently had a meeting with the Harare Municipality and requested they draft an amendment to the City By- Laws making it illegal for live animals to be sold at the side of the road. They have agreed to do so.

**HYENAS/BABOONS**: poisoning of Baboons in plantations in the Eastern Highlands and hyenas in the Plumtree area, continues to raise concerns – VAWZ is opposed to the use of poisons which cause animal suffering.

**CROCODILES**: continued inspection of farms at Binga, Vic Falls and Kariba.

**DONKEYS**: In the last week of May, Bernad and Meryl traveled a distance of 2211 Kilometres was traveled treating 157 donkeys in the Bulawayo, Gwanda, Beitbridge areas, donating harnesses, distributing education pamphlets and putting reflective tape on the back of scotch carts – the majority being in Beitbridge where cruelty cases are escalating and donkey welfare needs urgent attention. The Police take little action against the cruelty perpetrators, the Government Vet is concerned but has no vehicle and limited resources. VAWZ believes there is an urgent need for a permanent Donkey Clinic or Sanctuary to be set up in the area – to treat and educate- but aleast the Council there has installed a borehole at the Municipl e Pound after many months of meetings with VAWZ.

**MEETINGS/INTERVIEWS**: Meetings have been held with Dr. Majuru-Vet Dept, Govt. Vets-Marondera, Municipal Police. Interviews with a local farming magazine and a radio station.

**BREEDING PUPPIES**: Of concern are the numerous adverts in supermarkets and veterinary surgeries and emails advertising puppies for sale and male dogs for stud. Harare By-laws state:- "No person shall breed a dog or keep an unspayed bitch in the council area unless he is a registered breeder".

#### **PROSECUTIONS:**

1. Puppy Vendor – Pleaded guilty – Fined \$20.

2. 2 owners of over-loaded Cattle trucks - fined \$20 each.

3. Employer of worker (who fled back to China) fined \$40 for his employees crime of beating a Boerboel dog.

4. Worker on small holding who killed a pig with a hammer – fined \$20. Owner still to be charged when he returns from the U.K.

5. Part owner of 7 lions kept in captivity in the Chiredzi area – pleaded guilty to cruelty but appealed and was then Warned and Cautioned. Because of political interference we were sadly not able to bring justice to "Cubby" and the other 6 lions, who sadly last their lives.

We have another 9 cases pending.

### HARARE AGRICULTURAL SHOW:

For two weeks VAWZ Inspectors made daily checks on all the animals and during which they organized the euthanasia and removal of a badly injured cow; monitored a cow which gave birth to a still born calf; and another which gave birth to a healthy calf whose owner was eventually forced to return in a truck with a canopy to transport it home as opposed to their trying to load it into an open truck already fully loaded with drums, sprays etc. Police, Army

and Prison horses were all regularly checked as were the crocodiles, pythons, tortoises, pigs, chicken and rabbits. Food and shade material also supplied where needed.

Water continues to be problem and a permanent solution must be found as shortages are unacceptable especially with high temperatures. A list of concerns will be put forward by VAWZ to the General Manager of the Show Society.

#### **SPCA CENTRES**

Recently Meryl visited 6 SPCA's to deliver the final tranches of money that a friend of hers in the UK had been sending to her for the past two years for distribution to various centres. In addition VAWZ donated catching poles, syringes, needles, blankets, wound spray, Thiopentone, Euthapent, and latex gloves to these SPCA's. VAWZ particularly wanted to help the Gweru centre as staff there are keen to have an SPCA that plays a meaningful role in the community in preventing cruelty to animals. (There would be no SPCA in Gweru if it was not for volunteer Shirley Pornss and Kennel Manager Robert Munongo).

Having heard from them what Gweru SPCA was desperately in need of, Charlene our wonderful volunteer contacted all her friends at Avondale Sports Club who then donated in cash or kind. Last week VAWZ drove to Gweru and handed over 350kg of dog and donkey food, uniforms and wellington boots for the staff, Disinfectant, Jik, fly traps and fly smear, toys for the dogs and cats and many other goodies.

#### **TELL ME WHERE IT HURTS**

an excellent read by Veterinarian Dr. Nick Trout who graduated from vet school at Cambridge University in the UK and is now staff surgeon at the Augell Animal Medical Centre in Boston USA. He writes with great feeling about just how much pets mean to us. ""Pets devour the loneliness. They give us a purpose, responsibility, a reason for getting up in the morning and a reason to look to the future. They ground us, help us escape the grief, make us laugh and take full advantage of our weaknesses by exploiting our furniture, our beds, and our refrigerator. We wouldn't have it any other way. Pets are our seat belts on the emotional roller coaster of life – they can be trusted, they keep us safe and they sure do smooth out the ride".

For many years and up until the time of his death he was Principle Director of Livestock & Veterinary Services, a much loved veterinarian respected and revered around the world. His passing is a huge loss to the veterinary profession.

Another loss to the animal world is the death in a fire of Rita Miljo in South Africa. In 1989 Rita established The Centre for Animal Rehabilitation & Education – "CARE" – was established in a remote region in the Kruger National Park, a sanctuary for Baboons – primates that she once referred to as "nature's unwanted little people". Although she had retired Rita remained it's most visible presence.
