

National Social Security Authority (Accident Prevention and Workers' Compensation Scheme) (Prescribed Matters) (Amendment) Notice, 2013 (No. 18)

IT is hereby notified that the Minister of Labour and Social Services, in terms of section 3 of the National Security Authority Act [*Chapter 17:04*], hereby makes the following notice:—

1. This notice may be cited as the National Social Security Authority (Accident Prevention and Workers' Compensation Scheme) (Prescribed Matters) (Amendment) Notice, 2013 (No. 18).

2. This notice shall come into operation on the 1st of August, 2013.

3. The National Social Security Authority (Accident Prevention and Workers' Compensation Scheme) (Prescribed Matters) Notice, 1990, published in Statutory Instrument 68 of 1990 (hereinafter called the "principal notice"), is amended in section 2 ("Interpretation") by the addition of the following definition, "twenty-second appointed date means 1st August, 2013".

4. Section 35 (6) ("Amount of compensation where worker dies from accident") of the principal notice is amended in the proviso by deletion of "US\$200,00", and substitution of "US\$300,00", with effect from the twenty-second appointed date.

5. Section 43(5) ("payment of lump sum in lieu of pension or children's allowances") of the principal notice is amended in the proviso by deletion of the subsection and insertion of the following subsection—

"(5) The monthly amount fixed for the purpose of subsection (1) with effect from the twenty-second appointed date shall be—

- (a) worker – US\$45,00;
- (b) widow/widower – US\$30,00;
- (c) children – US\$15,00;
- (d) dependants – US\$15,00;

All pension in payment of this scheme shall be increased by 20% with effect from the twenty-second appointed date and any pensions that are lower than the minimums stated in this section after applying the 20% increase, shall be increased to the minimum set for the category in terms of that section.”.

6. Section 44 (“Where worker requires constant attendance”) of the principal notice is amended in the proviso by deletion of the words “twenty-first appointed date,” and the insertion of the words, “twenty-second appointed date”.

7. The principal notice is amended in the Sixth Schedule by the repeal of Part II and the substitution of the following—
