IT is hereby notified that the Minister of Finance and Economic Development has, in terms of section 235 as read with section 120 of the Customs and Excise Act [Chapter 23:02], made the following regulations:—

- 1. (1) These regulations may be cited as the Customs and Excise (Southern African Development Community) (Suspension) (Amendment) Regulations, 2013 (No. 13).
- (2) These regulations shall come into operation on 1st January, 2014.
