

Parks and Wildlife (Amendment of Fourth Schedule) Notice, 2014

IT is hereby notified that His Excellency the President, in terms of section 36 of the Parks and Wild Life Act [*Chapter 20:14*], and on the recommendation of the Parks and Wildlife Authority, hereby makes the following notice:—

Title

1. This notice may be cited as the Parks and Wildlife (Amendment of Fourth Schedule) Notice, 2014.

Alteration of area of Chirisa Safari Area

2. The area of Chirisa Safari Area, described in item 5 of the Fourth Schedule to the Act is altered by the subtraction of the area described in the First Schedule to this notice.

Amendment of Fourth Schedule to Cap. 20:14

3. The Fourth Schedule to the Parks and Wild Life Act [*Chapter 20:14*] is amended by the repeal of item 5 and the substitution of the item set out in the Second Schedule to this notice.

FIRST SCHEDULE (*Section 2*)

AREA SUBTRACTED FROM CHIRISA SAFARI AREA

The area drawn by section north of the Kove River and the Sesami Eastern game fence at map reference **35PK345940**, about 500 m south of Tank Dam where the game fence turns north on the 1:50 000 map (Tivuli Spring 1828A), Edition 2, proceeding generally north-westwards to the point **35PK298968**, 200 m after crossing an unnamed stream and then proceeding north-eastwards where it crosses Manyoni River at **35PL312010**; thence proceeding north-eastwards to the point where it crosses the road marking the Chirisa-Sengwa boundary at point **PL325050** and then north-eastwards to the Kandarianze area; thence proceeding to point **PL378084** in the Kandarianze area; thence proceeding generally northwards-northwest to a point **PL408085**; then proceeding south-eastwards to the game fence at point **PL445073**. Then starting from a point along the game fence at a point **PL500121** along the boundary at Tank 3; thence proceeding in a straight line north-wards to a point **PL470148** in the Mukusvu area, about 4 km from tank 3; thence proceeding north-eastwards to a point **PL478226** about 5 km south-west of Matsikanya Vlei; thence proceeding north-eastwards in a straight line to a point **PL518260** at Matsikinya Vlei, and then proceeding to cross the Gadzi River tributary at a point at **PLS27343**; thence proceeding

to cross the Gadzi River-Magurazino River confluence at **PL538380**; thence heading north-westwards to a point **PL481456** at Ruwanga along the game fence, then proceed north-east, then south-west along the previous boundary generally along the game fence through to point **PL500121** along the veterinary fence at Tank 3, before starting again at point **PL445073**, then proceeding generally southwards to the start point 500 south of Tank Dam at grid **PL345940**.

SECOND SCHEDULE (*Section 3*)

DESCRIPTION OF CHIRISA SAFARI AREA

The area of land bounded by a line drawn from the Tsetse and Trypanosomiasis control traffic-barrier known as Chipani Gate, at map reference **35KPL484095** on the 1:50 000 map Chipani Pan 1728C4, Edition 1, generally north-eastwards to a point at Tank 3, at map reference **35PL500121** thence proceeds in a straight line north-wards to map reference **PL470148** in the Mukusvu area; thence proceeding north-eastwards to a point **PL478226** about 5 km south-west of Matsikanya Vlei; and then proceeding to cross the Gadzi River tributary at a point at **PL527343**; thence proceeding to cross the Gadzi River-Magurazino River confluence at **PL538380** on the map Chidoma 1728C2; thence heading north-westwards to a point **PL481456** at Ruwanga. From Ruwanga it heads generally in south-westwards along the cut line to its intersection by a cleared track at map reference **35PL155274** on the 1:50 000 map Domwe 1728C3, Edition 1, thence generally southwards along that cleared track to where it is intersected by the northern Sebungwe game fence at map reference **35PL089028** on the 1:50 000 map Tivuli Spring 1828A1, Edition 1. Thence eastwards along the northern Sebungwe game fence to the Link game fence at map reference **PK115898** on that map, thence south-eastwards and north-eastwards along the southern Sebungwe game fence to the Sessami game fence at map reference **PK345940** on the 1:50 000 map Charama 1828A2, thence proceeding generally north-westwards to the point **35PK298968** on the 1:50 000 map Domwe 1728C3, Edition 1, thence proceed north-eastwards to the Kandarianze Pan at map reference **PL378084** on the 1:50 000 map Tivuli Spring 1828A1, Edition 1, thence proceed in a straight line south-eastwards to the game fence at point **PL445073**, thence heading north-eastwards to the starting point at Chipani Gate, at map reference **35KPL 484095** on the 1:50 000 map Chipani Pan 1728C4, Edition 1.
