# EXECUTIVE NEWS

No speculation or predictions about the weather this week, only to say that some places in Harare had some fairly heavy showers last night, which was accompanied by some pretty heavy thunder and lightning. Let's hope this is an indication that the rains are not too far away.

Rather a quiet week again as most of the senior members have been away at meetings and with Director Hendrik Olivier attending the AgriSA Congress in South Africa this week.

That most certainly does not mean that nothing is being done though as there is more than enough work to keep busy with especially with the build-up to our own Congress, which is literally just around the corner.

Today, President Taffs and Vice President Steyl have undertaken a trip to Mutare to speak to our farmers there. They will be back in the office on Monday, although Vice President Steyl will then be heading for another sponsored SACAU workshop to be held in South Africa.

Yesterday a further meeting was held by the task force elected to formulate plans for the formation of the Federation of Agricultural Unions. Recommendations from this meeting will be taken to CFU Council and the ZFAT (Zimbabwe Farmers Alliance Trust) Trustees for further debate and clarification prior to adoption.

A copy of the proposed Bill for the necessary legislation for the establishment of the National Land Board have been circulated to us for our recommendations to be presented at an open meeting in the middle of next week. We are going through this rather lengthy document together with likeminded organisations and also consulting with the legal brains before putting together our proposals which will be circulated. The establishment of this board is in line with the recommendations of the newly adopted Constitution.

At our initial glance at the proposed Bill, in our opinion the powers of the Minister of Lands were seen as far too dominant to leave much left for the board to consider, but we do appreciate the fact that at least we have been consulted, albeit only a very few days before the allotted time for submissions.

Although the response to our membership drive and payment of subscriptions has been a fair success and we sincerely thank those who have responded so promptly, it was most certainly much slower

The state of Play

Despite the recent upheaval, which is now resolved, work continues unabated.

In terms of the Fast Track Land Reform Program hereafter FTLRP there were 5596 farms taken covering 7,485,748 ha. The database and our GIS mapping is definitive on this. Any other figures are based on different criteria e.g. including smallholdings or just plain wrong.

Fully registered on the database are 4352 farms covering 6,123,955 ha. Unregistered but with partial information 990 farms amounting to 1,213,898 ha. There are 254 farms with no information covering 147,895 ha.

In simple terms 84% registered; 15% partial information unregistered; less than 1% unknown.

The 15% are the problematic but I personally believe that we will find that a good portion are not compensatable for various reasons and some may be untraceable. As we progress we have discovered the truth of this as a number have been sold to indigenous farmers or have accepted compensation.

The figure of 85% has been mooted by the World Bank and Donor bodies as being acceptable in terms of a complete workable exercise. We are on the brink of achieving this but as many will know the last step is like pulling teeth.

Progress on the compensation issue.

We continue with our contacts with the Donor Community, The World Bank and top Government officials. If nothing else we have established the extent of the problem and have assurances from the highest levels that there is a willingness to face the issue. We are more optimistic now than at any time since the beginning of FTLRP.

#### FAQ's

We are often questioned along the following lines and hopefully we can explain;

Q. why are you not putting values on farms?

Two reasons 1. Technical i.e. we do not know the basic criteria, method or date of valuation, any valuations we do will probably be wrong. 2. At this stage any values we produce in the public domain will inevitably be controversial and lead to confrontation with the parties who will be part of the process. Rest assured that given the right criteria we can produce all the valuations and a Global Sum in the matter of hours.

#### Q. If the Colonial Power is required to pay for 'Land' why don't you value that?

A. again we do not know the basic criteria, method or date of valuation, but it is even more problematic in that the value of Improvements is meant to be a residual after Land Value is deducted from Market Value. We are forced into the opposite position where we must value Improvements first and this is currently an unknown. The Colonial Power of course does not accept the liability at this stage and again to go public would cause a confrontational situation with little chance of resolution.

**Q.** If it is the Governments duty in terms of the Act to pay for improvements and they can't afford it, who will pay.

A. It is now broadly accepted by all parties that the level of liability i.e. the Global Sum must be established first. There are many plans and possibilities for payment ranging from Bonds to IMF loans but all of these are subject to a return to a normal financial climate. Hopefully this is closer than we think.

Q. The role of the World Bank

A. Quite simply they are facilitators. They have arranged studies on relevant Land Issues including Compensation and have supported us and enabled funding to the Min of Lands to set up the processes, They are not part of the compensation process per se and will not be responsible for providing funds for actual compensation.

# Valcon Funding

The Valcon Database and GIS mapping are high tech and substantial, they are operated by full time employees and two inhouse Valuers from a dedicated office.

We operate as economically as possible but it is still a relatively expensive operation. Visit us to see for yourself.

Maize delivery to GMB

The Grain Marketing Board has said that it has so far received 178 948 tonnes of maize from farmers indicating <u>a 542% increase</u> compared to the same period last year when it had received 27 890 tonnes. The GMB is buying maize at US\$390 per tonne and farmers are urged to deliver their maize and small grains directly to its depots countrywide.

Debt

Seed Co has said that Government will need to clear its obligations from last season's farming inputs supplies to get new credit for its input scheme this year. Chief Executive Mr. Morgan Nzwere said all seed houses in the country expected to be paid, as they could not afford to keep supplying without being paid for last season's supplies. Annual inflation trends downwards

According to the Zimbabwe National Statistical Agency, the annual rate of inflation trended downwards after shedding 0.06 percentage points from the August rate of 0.15% to 0.09% in September 2014. The International Monetary Fund projected inflation to end this year low, around 0.2 percent rising to 1.2 percent in 2015, a starkly different scenario to the era of hyperinflation

Potash related problems are certainly not new to crops in Mississippi, but this year we have had a reminder of how important this element is. There is no mystery to the story of potash nutrition, but many of us are questioning the reason for increased incidence of this problem in 2014.

By now most of the people who read these articles have come to accept that I discuss some subjects that are not fully "fleshed out". Some of these subjects are minor while others have shown themselves to be capable of causing differences in the profitability of crops. They need answers, often sooner than the research community can provide them.

In these situations we can at least discuss these issues in light of the things we know. Sometimes we may not find a good answer for the question for years or maybe never, but we can find possible interactions, likely contributing factors, and means of avoidance in the short term.

During one of my visits to a farm in the southwest part of the state I ran across an example of severe potash deficiency in soybean. A field which had low soil test potash had received a fairly moderate rate of potash fertilizer at planting and the crop had responded well to it. Plants did not show deficiency symptoms for this element, except that in one field the grower had run out of potash and had not been able to and complete the application on a portion of one field. This area exhibited the worst potassium deficiency I had ever witnessed in soybean with some plants almost dead as a result. Less than five feet away from severely affected plants were normal plants with good yield potential. This confirmed to me that in cases of potash deficiency the element should be applied in spring rather than fall, especially on sandy or silt loam soils.

Another example of the importance of good potash fertilization has been the incidence of verticillium and fusarium wilts in cotton, along with high incidence of the common leaf blight diseases. These problems have been extremely common in cotton fields all over the region this year and in many cases can be linked to soil test potash levels that are less than ideal.

We have also witnessed the presence of another wilt-like disease in cotton that resembles verticillium but does not discolour the xylem tissue of the stems as in verticillium. With this disease the plants wilt and defoliate much like plants infected with verticillium, but when we do the customary stem splitting test for verticillium diagnosis the stem is found to be free of any discoloration. In some fields where this condition has been found other plants may show the symptoms of verticillium, suggesting that both this newcomer and verticillium may be present.

I understand that efforts are being made to determine the severity of this new disease that has contributed to early senescence and defoliation of several fields of cotton in this region, however it would be premature to suggest that we know everything we need to know about it. Personally, I feel that the extended period of frequent rainfall during the early portion of the growing season produced shallow rooting, thereby limiting the amount of soil accessed for potassium and other elements. Other issues that may limit the availability of micronutrients needed to combat disease may also be involved. Hopefully we will soon have a better handle on the reason for this problem so that we can plan to avoid it in the future.

For now, we need to concentrate on what we know. Fields that were affected should be sampled and tested, along with other fields that have not been tested recently. As I always say, if you guess about soil fertility you will sooner or later guess wrong. Can you afford to be wrong?







Livestock feed industry registers growth (From LMAC)



The mid-year sector report of the Stockfeed Manufacturers' Association indicates continued growth in the industry. Based on information supplied by Agrifoods, Capital Feeds, Feedmix, Fivet Animal Health, Hamara Feeds, Hyperfeeds, Ice Feeds, Irvines Zimbabwe, Lake Harvest, Manyame Milling, National Foods Ltd, Novatek Animal Feeds, Profeeds, RimaiTidye Feeds and Triple C Pigs, the report indicates that average monthly feed production between January and June 2014 was 34 578 metric tonnes, representing a 16 percent increase over the same period in 2013.


Growth in the feed sector was largely driven by the poultry producer sector. In the first six months of 2014, poultry feeds accounted for 74 percent of all feeds produced.

Broiler feeds in the first half of 2014 were 20 percent higher than feeds produced over the same period in 2013, driven by the growth in broiler day old chick production, which increased by 17 percent over the same period.

The report also shows significant growth in the production and sales of other feeds in the first half of the year compared to the same period in 2013.

Dairy meals, beef fattening meals, fish feed and pig feed production grew by 57, 30, 10 and 3 percent, respectively. These figures reflect positive growth in the respective livestock sub-sectors.

However, despite these positive growth signs, there are a number of threats facing the industry.

These include:

Dumping/smuggling of various meats into the country

According to the chairman of the Stockfeeds Manufacturers' Association: "Because of our position as a country with the highest cost of grains (maize and soya), which means highest prices of meat and livestock products, individuals have seen opportunities to smuggle in or dump various meats, particularly chicken and pork, to the detriment of local producers of meat.

"The local poultry market is close to collapsing right now and producers, who are the small-scale and communal in the majority, are scaling back or stopping production all together.

"This is our biggest threat because the poultry industry accounts for 74 percent of our stockfeeds and when they sneeze, the stockfeed industry catches a cold."

Maize marketing policies

The chairman also highlighted the issue of the minimum maize price as a threat to the feeds industry.

"For example, the recently gazetted Statutory Instrument 122 of 2014, which was enacted on 8 August 2014, was meant to increase the return to maize farmers.


"But the authorities forgot that maize is a key raw material in stockfeeds, and Zimbabwe is struggling to compete in the region (that is why cheap imports are destroying our livestock industries).

"Our regional competitors pay their farmers about \$250 per tonne, compared to our declared price of maize of \$390 per tonne, making the prices of their feed costs, and hence meat products prices, much lower.

"This creates incentives for smugglers of cheap meats to flood our markets to the detriment of our livestock producers."


