Appointment and Assignment of Functions: Vice Presidents, Ministers, Deputy Ministers and Permanent Secretaries

IT is hereby notified that His Excellency, the President has—

- (a) in terms of section 92 as read with paragraph 14 of the Sixth Schedule of the Constitution, appointed the Vice Presidents in the first column of the First Schedule and assigned to them the designation and administration of the office opposite their names in the second column of that Schedule;
- (b) in terms of section 105(1), of the Constitution, appointed the Ministers listed in the first column of Part I of the Second Schedule and assigned to them the designations and administration of the Ministries specified opposite their names in the second column of that Schedule;
