[CONSTITUTION

Assignment of Functions (Minister of Lands, Agriculture and Rural Resettlement) Notice, 2018

IT is hereby notified, that His Excellency the President has, in terms of section 104(1) of the Constitution as read with section 37(2) of the Interpretation Act [*Chapter 1:01*], assigned to the Minister of Lands, Agriculture and Rural Resettlement—

- (a) the administration of the Acts set out in the Schedule; and
- (b) the functions conferred or imposed on the Minister of Lands, Agriculture and Rural Resettlement save to the extent that those functions have not been assigned to some other Minister.

Assignment of Functions (Minister of Agriculture, Mechanisation and Irrigation Development) Notice, 2014, published in Statutory Instrument 9 of 2014, and Assignment of Functions (Minister of Lands and Rural Resettlement) Notice, 2014, published in Statutory Instrument 24 of 2014, are hereby repealed.
