Plant Pests and Diseases (Importation) (Amendment) Regulations, 2019 (No. 4)

IT is hereby notified that the Minister of Lands, Agriculture and Rural Resettlement has, in terms of sections 8 and 29 of the Plant Pests and Diseases Act [Chapter 19:08], made the following regulations:—

- 1. These regulations may be cited as the Plant Pests and Diseases (Importation) (Amendment) Regulations, 2019 (No. 4).
- 2. The Plant Pests and Diseases (Importation) Regulations, 1976, published in Rhodesia Government Notice 154 of 1976, are amended by the repeal of the First Schedule and substituted by the following—
