3. When giving an Application Number to an Application, the District Land Inspector should insert in brackets the District Code Number as the one applicable to NIDs and then insert the Application Number and the year. eg; Lease Application Number 12 of 2005 in the District of Nyanga in Manicaland should be written as follows:

  - b. Proof of applicant’s previous (up to 5 years) Farm/Plot produce supplies to GMB, CMB, Tobacco Auction Floors, Pig Industry Board, CSC etc.
  - c. An original and a certified true copy of a valid offer letter.
  - d. An original and a certified true copy of applicant’s National ID.
